It is great to get feedback from those who already like (love) CIHS. How to reach the people outside the reach of survey respondents? Personal conversations seem to be key.

The responses about environmental issues are very high. This may be a way to draw younger families in – summer program?

At recent conference about historical societies, there were presentations that it is the responsibility of a historical society to address climate change.

How to reach younger generations? What tools?
